### GUIDELINE FOR THE SUBMISSION OF IMPORT OR EXPORT PERMIT DECLARATIONS FOR THE IMPLEMENTATION OF THE ASEAN AUTHORISED ECONOMIC OPERATOR MUTUAL RECOGNITION ARRANGEMENT (AAMRA): INDONESIA



Following the Customs Notification No. 188/2567, effective since 17 October 2024, Business Operators importing goods from Indonesian AEO companies can now enjoy privileges on trade facilitation on customs procedure.

To ensure a smooth implementation and provide comprehensive information for importers interested in AAMRA benefits, the Customs Department, endorsed by ASEAN Member States, has launched the **Guideline for the Submission of Import and Export Permit Declarations for the Implementation of the ASEAN Authorised Economic Operator Mutual Recognition**, companies import from Indonesia traders will be able to receive AAMRA benefits by following this guideline.

**GUIDELINE FOR THE SUBMISSION OF IMPORT OR EXPORT PERMIT DECLARATIONS FOR THE IMPLEMENTATION OF THE ASEAN AUTHORISED ECONOMIC OPERATOR MUTUAL RECOGNITION: INDONESIA**

In order to receive the AAMRA benefits, Thai importers are required to declare this following information through Thai Customs Electronic Systems (TCES):

1. AEO MRA Exporter Name
2. AEO MRA Country Code: ID (Indonesia)
3. AEO MRA Reference Number

Importers are required to declare the reference number in the same manner as this following template.
